Re: Freedom of Information Act Request

Dear Sheriff's Office Bureaucrats,

This is a request under your Freedom of Information Act.

I request that a copy of the following documents [or documents containing the following information] be provided to me:

**Regarding the Cheshire County House of Corrections:**

I request to attain a copy of the footage and audio from all of the cameras in the Cheshire County House of Corrections from the hours 10pm Friday September 9th 2011 to 11am Saturday September 10th 2011. This includes, but is not limited to, cell B-104, the cell in which I was caged.

I want a copy of the audio recording of all conversations between call boxes. I request an audio copy of the radio transmissions between all officers between the hours of 2pm and 11:59pm Friday September 9th 2011.

**Regarding the City of Keene Police Department:**

I request to attain a copy of the footage and audio from all of the cameras in the Keene Police Department from 9pm Friday September 9th 2011 to 11:30am Saturday September 10th 2011.

I request an audio copy of the recording of calls to the Keene Police Department.

I request a paper copy of the list of calls for which the Keene Police Department was dispatched and a transcript of those conversations.

I request a paper copy of the Police Report about the 4 arrests in Central Square between 10pm and 11:59pm on Friday September 9th 2011.

If you estimate that the fees will exceed this limit, please inform me first.

I request to attain a copy of the footage and audio from all of the police cars called to Central Square on Friday, September 9<sup>th</sup>, 2011 between the hours of 10pm and 11:59pm.

I request an audio copy of the radio transmissions between all officers between the hours of 2pm and 11:59pm Friday September 9th 2011.

I request a copy of the Police Manual for the Use of Mace.

I request a copy of the Police Manual for the justifications of use of force.

I request a copy of the Police Manual for definitions of the following: force, discretion, obstruction of government administration, arrest, resisting

I request a copy of the Police Manual for using flashlight.

I request a copy of the police manual for deterring video recording.

I request a paper copy of the list of calls for which the Keene Police Department

was dispatched and a transcript of those conversations on Friday September 9<sup>th</sup> 2011 between 10pm and 11:59pm.

I request of copy of the police report of my arrest on Friday September 9th 2011.

I request an audio copy of the recording of calls to the Keene Police Department.

I request to know what police cars and officers were called to Central Square by Dispatch between of 10pm and 11:59pm Friday September 9th 2011.

I request to attain a copy of the footage and audio from all of the police cars called to Central Square between 10pm and 11:59pm Friday September 9th 2011.

I request an audio copy of the radio transmissions between all officers between the hours of 2pm Friday September 9th 2011 and 11:59am Saturday September 10th 2011.

In order to help to determine my status to assess fees, you should know that I am an individual seeking information for personal use and not for commercial use.

I am willing to pay fees for this request up to a maximum of \$5.

If you estimate that the fees will exceed this limit, please inform me first.
